

**Rules / General information**  
**Open call / Online residency program**  
**at Baltic Gallery of Contemporary Art in Słupsk**  
**Miejsce – wewnątrz / Place – Inside**

1. These rules set forth the terms of participation in online residency program „Miejsce – wewnątrz” / ‘Place – Inside’.
  2. The Program is organized by the Baltic Gallery of Contemporary Art with its seat in Słupsku (76-200), ul. Partyzantów 31 A, Regon 000678239, NIP 839-17-76-423.
  3. Online residency program is open for polish and foreign artists, at every stage of artistic career, deals with various art disciplines (performance, video art, internet projects, animation, photography, drawing).
  4. The subject of the program is participation in eight-week online residency program in collaboration with curator of artistic residency program.

### **Submission /**

1. To participate in the recruitment process, it is required to submit a complete application in Polish or English containing:
    - personal data: full name, e-mail address, mobile-telephone number, address of residence,
    - description of project proposal (maximum 500 words),
    - portfolio (pdf file, link to Website... etc.)

  3. Incomplete applications will not be considered in the selection process. Artist may send one project.

### **Selection of winners /**

1. The project will be selected by the committee including BGSW staff.
  2. The results of enrollment will be published on organizer website and social media. We will inform selected artists via e-mail.
  3. The organizer’s decision shall be final and unappealable.

### **Accession to the Program means /**

1. The artist give consent to voluntary, specific, conscious and unambiguous demonstration of a will in the form of a declaration of participation as a clear act authorizing the processing of personal data concerning.
2. The artist accepts the rules of the online residency program.
3. The artist accepts the schedule of the online residency program.
4. The artist accepts the main subject of the online residency program proposed by organizer.
5. The artist agrees to participate in consultations with the curator of the program and meetings with artists participating in the form of a video chat.
6. The artist agrees to participate in 3 meetings (according to the schedule) presenting the activities

of the organizer, the assumptions of the online residency program, documentation of previous works, stages of the project in the form of a video conference.

7. The artist agrees to present the documentation of the meetings on the organizer website and on the organizer's profiles on social media (Facebook Instagram, YouTube).
8. The artist agrees to participate in the final meeting, which will be a summary of the online residency program, as a video conference presented on the organizer website and on the organizer's profiles on social media (Facebook, Instagram, YouTube).
9. The artist grants a free license to present the documentation of his previous implementations, stages of work on the project and the final result of the artwork (organizer website, profiles on social media – Facebook, Instagram, YouTube) at a time determined by the curator and the artists.

## **General terms /**

1. The organizer does not offer a fee for participation in the project and reimbursement of costs of materials used during the project implementation.
2. The artist declares that he is the sole creator of the project and that none of its elements infringe the copyrights of third parties.
3. The artist declares that he is not involved in any other project that prevents him from participating in online meetings.
4. The organizer reserves the right to change the rules and the schedule of the program.
5. In case of random events, changes of the online residency schedule are acceptable.
